What is it?

The measure is aimed at supporting families in striking a balance between professional and family life through the enhancement of the local services targeted towards children and teenagers.

The funded actions involve:

- Assistance and childcare services targeted towards minors in order to support the relative providing assistance
 - services for the management of the pre- and post-school periods and the periods when schools are closed
- (Summer camps and schools, after school care, etc.);
- support services for the fruition of leisure activities targeted towards minors (e.g. ongoing support, sports and leisure activities, visits to parks/museums, etc.);
- information and guidance on the local services targeted towards children and teenagers.

What are the benefits?

- If you are a member of a partnership: you can provide trade-off services, the cost of which will be reimbursed to you by the Lombardy Region
- If you are a citizen: you can access trade-off services for free or at a discounted price

Who can aplly?

Project proposal are to be presented by **partnerships** made up of at least three entities falling under the following categories (beneficiary/actual partners):

- Local public bodies;
- Bodies in operation accredited for the management of
- social and/or healthcare offers;
- Third-sector organisations enrolled in the regional or
- national registers or similar regional/national lists;
 - Bodies accredited by the religious denominations with
- which the State has entered into deals, agreements, or understandings.

At least one public entity must be included among the beneficiary partners.

Moreover, the partnership can be joined also by associates and/or sponsors falling under categories other than those envisaged for actual partners, as long as they share the goals of the project and take part in the project activities without benefitting from their contribution.

Where to submit the application?

The application for participation is to be submitted by the Lead Partner solely through "BandiOnLine"

The public contribution is acknowledged upon assessment of the presented projects on the part of the Board of Evaluation.

Free nurseries 2018-2019

What is it?

The measure is aimed at supporting economically and socially vulnerable families and facilitating access to early childhood services by responding to the need of striking a balance between personal and work life, thereby reducing to zero the tuition that families are to pay in order to have their children attend public or public nurseries and micro-nurseries (for places purchased by the Municipality admitted to the measure).

The measure consists of two phases: the first phase envisages an announcement to be issued on the part of Municipalities (already published on the Official Bulletin of the Lombardy Region on 7th June 2019).

The second phase envisages an announcement with regard to the participation of families, to be published no later than September 2018. The relevant prerequisites shall be made known on that date.

What are the benefits?

The tuition required for attending nurseries it reduced to zero

- The Municipality with which the family interacts with regards to the nursery has joined the initiative;
- The child is enrolled in and attends a nursery/micro-nursery admitted to the Measure;
- The fees applied by the Municipality in compliance with the municipality rules – are differentiated based on the ISEE categories;
- With regard to affiliated nurseries, the place occupied by the child is included among the ones acquired by the Municipality granting the affiliation;

What are the necessary prerequisites?

The families are to meet the following prerequisites:

- An ISEE ordinario/ISEE corrente/ISEE minorenni indicator (should the Municipality require it in order to apply the fee) not exceeding 20,000 Euros;
- Both parents living in Lombardy;
- Either two employed parents or one employed parent and one unemployed parent with a DID (*Dichiarazione di Immediata Disponibilità*, Declaration of Immediate Availability) and a PSP (*Patto di Servizio Personalizzato*, Personalised Service Pact) pursuant to Italian Legislative Decree no. 150/2015^I. In the presence of single-parent units, the parent can be employed or unemployed with a DID and a PSP pursuant to Italian Legislative Decree no. 150/2015.

Please note that unemployed parents should:

- Have already subscribed the DID when submitting the application;
- Subscribe the PSP within four months from submitting the application, under penalty of the application not being admitted.

Where to submit the application?

The application for financial contribution is to be submitted **online** through the information system dedicated to tenders by entering the PIN of the European Health Insurance Card or the SPID (Public Digital Identity System).

#Teenagers

Teenagers

What is it?

It is an instrument ensuring the provision of targeted, flexible, integrated solutions to distressed teenagers and their families on the part of local services, which implement initiatives targeted towards social inclusion.

What are the benefits?

- Teenagers are helped to take the lead in addressing their distress
- Teenagers' family and social relationships are improved in order to enhance their quality of life


What are the necessary prerequisites?

Families with adolescent or young children aged between 13 and 25 (art. 5 of Italian Legislative Decree no. 92/2014, converted into Italian Law no. 117 of 11th August 2014) living in Lombardy and experiencing situations of distress such as:

- Developmental and psychological disorders (e.g. problematic family relationships, stressful lives, eating disorders, deviance and involvement in high-risk groups);
- **Social isolation** (e.g. inability to adapt, psychological and behavioural disorders, social withdrawal, bullying/cyberbullying);
- Early school leaving (e.g. school/educational failures);
- Addictions (e.g. alcohol, drugs, gambling);
- Judicial problems (e.g. antisocial, criminal or disruptive behaviours, criminal or administrative problems for brawls or possession of illegal drugs).

Where to submit the application?

The application is to be submitted by the reporting institution to the ATS (Health Protection Agency)/ASST (Local Healthcare Unit).



#Vouchers for elderly and people with disabilities

Which requirements

Vouchers for the elderly and people with disabilities

What is it?

It is a voucher that allows access, following a multidimensional evaluation carried out by a team of

professionals, to personalized interventions agreed with the territorial reference services of the total value of 4,800 euros.

What are the benefits?

With the voucher you can get benefits in favour of:

- elderly people to promote well-being, the maintaining the cultural level, autonomy personal and quality of life;
- **people with disabilities** to enhance individual skills to order to improve social skills, the maintenance of cultural level, personal autonomy and inclusion social.

What are the necessary prerequisites?

The voucher is targeted towards **elderly people** who:

- Are aged 65 or more;
- Live at their home;
- Have a reference ISEE income amounting to a maximum of 20,000 Euros.

And find themselves in the following conditions:

- Suffering from a functional impairment or other conditions entailing a lower level of care as to oneself and one's domestic environment, as well as social problems resulting from a decrease in family and friendship relations, with a subsequent worsening of one's psychological and physical conditions;
- Being the relative of a person requiring assistance and support for the purposes of maintaining of a good quality of life.

The voucher is targeted towards young people and adults living with disabilities entailing a high risk of social exclusion who:

- · Are aged 16 or more;
- Have an ISEE income amounting to a maximum of 20,000 Euros;
- Have such a level of functional impairment as to enable them to embark upon a path revolving around the acquisition of social, self-care and home maintenance skills.

Moreover, said people are to possess:

- Functional abilities suitable for undergoing socioeducational interventions targeted towards the acquisition of the necessary self-care skills;
- A level of skill as to everyday activities allowing for socio-educational and socio-cultural interventions aimed at developing/enhancing/reacquiring:
 - · Relational and social skills;
 - The ability to take part in family activities or emancipate themselves from them;
 - Skills suitable for start/resume work

The voucher cannot be requested by people taken in charge of on the part of local services (social-educational centres, training services on autonomy) for more than 18 hours per week.

Where to submit the application?

To take part in the measure, fill in the form available online on the website

and return it to the relevant local services, which will verify the presence of the necessary prerequisites and draft the customised plan based on the needs expressed by the individual and shared by the operators.

The overall budget allocation for the initiative amounts to 6 million Euros.

#Marginalisation

Marginalisation

What is it?

It is a measure aimed at consolidating initiatives revolving around social inclusion, with the goal of reinserting into society young people and adults at risk and/or experiencing exclusion and marginalisation, including substance abusers and/or homeless people.

The interventions are also targeted towards citizens, especially those who live and work in their own district, with the goal of improving the quality of social life and lessening the impact of existing conflicts.

This measure is characterised by the **customisation of interventions**, which in turn determine different modalities whereby social inclusion is achieved.

What are the benefits?

The measure enables the various participating organisations to present projects for the promotion of virtuous social inclusion processes at a community level by use of actions falling within the following intervention areas:

- 1. Social mediation
- 2. Risk prevention and mitigation
- 3. Damage pinpointing and reduction
- 4. Active inclusion

What are the necessary prerequisites?

The projects can be presented by partnerships made up of public bodies (individual or associated municipalities, ATSs, ASSTs and other public bodies operating at a local level), managing bodies accredited for the management of social and/or healthcare offers, third-sector organisations enrolled in the regional registers, bodies accredited by religious denominations and bodies accredited for training and work, coordinated by a Lead Partner reporting to the Lombardy Region.

Upon publication of a specific announcement, the Lead Partners will be able to present their projects through the "BandiOnLine" system

#Integration

Judicial Authority

Social and work integration of people subject to measures issued by the Judicial Authority What is it?

It is a series of projects implementing what envisaged by the Regional plan for the active social inclusion of people subject to measures issued by the Judicial Authority, which pursues the following goals by integrating instruments and carrying out complementary interventions:

- *Customising educational and pedagogical interventions and integrating the person subject to the measure into the family context;
- Attaching great importance to the daily activities of the concerned person by listening to their needs and ensuring the support of Service Providers;
- Acting locally in constant coordination with the Prison Administration, Juvenile Justice and Community systems and the system for the provision of services to people.

What are the benefits?

The approved projects authorise interventions that will be carried out both within Penitentiary Institutions for adults and minors (#prison) and at a local level.

These interventions enable people to embark upon reintegration paths starting from the very incarceration phase: the initiatives focus on training, the provision of educational and psychological support, preparation for the labour market and temporary reception.

The Incentive that will be granted to the Body submitting the application consists in a non-repayable grant that is generally co-financed by the very beneficiaries (Bodies) for a sum amounting to at least 20% of the cost of the very project.

The interventions are targeted towards:

- Adults subject to measures issued by the Judicial Authority and their families (including adults under house arrest);
- Minors and young adults subject to measures issued by the Judicial Authority and their families;
- Adults, young adults and minors who have reached the end of their sentence and their families, within the year following the end of the sentence;
- Adults, young adults and minors under probation.
